“3-K For All” Rolls Out A Year Early in East New York!

Mayor de Blasio and NYC Schools Chancellor Farina announced today that 3-K For All will expand to four more community school districts over the next three years. This increases the city’s commitment to fully funding free, full-day, high-quality 3K to twelve school districts by 2020. This will double the number of new districts opening this fall.

Starting in the 2018-19 school year, the city will expand to additional districts each year which now includes the following districts:

- * 2018-19: District 5 (Harlem) and District 16 (Bed-Stuy)
- * 2019-20: District 6 (Washington Heights and Inwood)
- * 2020-21: District 12 (Central Bronx)

& East New York’s very own School District 19 in the 2019-20 school year as well. The expansion to our district was actually pushed a year earlier than scheduled.

Families can apply to 3-K and Pre-K starting Monday, February 5th, 2018.

To submit an application online go to: www.nyc.gov/3k and for Pre-K online at www.gov/prek. All families can apply over the phone by calling 311 or in person at a Family Welcome Center. The online application is available in 10 languages, and families can submit an application over the phone or in person in over 200 languages. 3-k and Pre-k enrollment specialists on sites across each neighborhood, will be available to help families throughout the process to identify a program that best fits their child’s needs.
